#### Nary Inc.:

Sue Adkins informed the board the Hubbard County can do a search by Helga Township to find conditional and interim use permits and copy them for a dollar a page. We would then be able to have complete documents and an ordinance book.

#### GIS:

As a township we can get the GIS Mapping access for free and Sue has made application to get the user name and password. We will be able to print labels and do research.

#### **Ordinance Meeting:**
