Fire Report Dana will attend the quarterly meeting on April 27th. Discussion will be held on having fire bills sent that detail what the billing covers. Also there will be a request to have monthly fire call reports and to have an in person yearly visit by the fire chief to all townships at their regular meetings.

Road Report See road tour reports of all road work that needs doing. Motion by Don seconded by Kip to have Bro Mowing do the minor repairs detailed on the report. Don is currently trying to get cost information from Buness Gravel for the graveling that will be done on needed roads this summer. A report was made of a new hole on Union Road. Barry will put a cone in that spot until repairs can be made.
